Grant Terms and Conditions for Communication System Enhancement

These terms and conditions ("Terms") outline the agreement between the grant applicant ("Applicant") and Your Comms Group, hereinafter referred to as the "Provider," for the allocation of funds up to £3000 towards the acquisition of a new phone system, mobile devices, data plans, or broadband services, collectively referred to as "Communication System."

1. Eligibility:

- 1.1 The Applicant must be a registered limited company/corporation operating within the United Kingdom.
- 1.2 The Applicant must demonstrate a legitimate need for upgrading their existing communication infrastructure or establishing a new one.

2. Grant Amount:

2.1 The amount of the grant awarded to the Applicant will be determined by Your Comms Group and would be based on the number of users intended to benefit from the Communication System and also the solutions/products they require.

3. Application Process:

- 3.1 The Applicant must submit a complete grant application through the online forms provided by the Provider. The application should include relevant information about the organisation, the purpose of the Communication System, the estimated number of users, and the anticipated budget they have available for maintaining the solution.
- 3.2 The Applicant agrees to provide accurate and truthful information in the grant application. Misrepresentation of information may result in the rejection of the application or the revocation of the grant.

4. Selection Process:

- 4.1 Grant recipients will be selected at the discretion of the Provider based on the eligibility criteria, the proposed use of funds, and the potential impact of the Communication System on the organisation.
- 4.2 The Provider reserves the right to reject any application without providing specific reasons for the decision.

5. Fund Usage:

- 5.1 The funds granted must be used solely for the purpose of acquiring or upgrading the Communication System as described in the application.
- 5.2 The Applicant shall provide documentation, such as invoices and receipts, to demonstrate that the funds were used in accordance with the grant's intended purpose.

6. Grant Disbursement:

6.1 Once the grant is approved, the funds will be disbursed to the Applicant through a method determined by the Provider. Typically the grant will be provided in the form of a discount across the term of the order.

- 7. Termination and Recoupment:
- 7.1 The Provider reserves the right to terminate the grant agreement if the Applicant fails to comply with the terms and conditions outlined herein.
- 7.2 In the event of non-compliance or misuse of funds, the Provider reserves the right to recoup the granted funds or take legal action to recover the misused funds.
- 8. Amendment of Terms:
- 8.1 The Provider reserves the right to amend these Terms at its discretion. Any changes will be communicated to the Applicant through written notice.
